श्री. एस श्रीकांत, कार्यालय अधीक्षक को वेतन मेट्रिक्स (रु.47,600-1,51,100) के स्तर-8 में कार्यालय अधीक्षक के ग्रेड में, तत्काल प्रभाव से और अगले आदेशों तक नियमित आधार पर पदोन्नत किया जाता है। Shri. S Sreekanth, Office Superintendent, O/o CCIT Trivandrum is hereby promoted on regular basis to officiate in the grade of Administrative Officer Grade-III in Level-7 of the pay matrix [Rs.44,900-1,42,400] with immediate effect.

2. On promotion to the cadre of Administrative Officer Gr.III, the official is placed at the disposal of O/o CIT(TDS), Kochi for posting at Trivandrum.

3. The promoted official will be on probation for a period of 2 years. During this period, the above promotion will not confer on the promoted official any right either to retention or to seniority in the promoted cadre.

4. Fixation of pay of the above official in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of official for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned Head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanction the same.

5. The above promotion/seniority is provisional owing to the outcome of the following cases.  
i) Special Leave Petition to Appeal No.30621 &Ors. Vs. Lachmi Narain Gupta &Ors.and all other related cases pending before the Hon'ble Supreme Court.

ii) Outcome of various decisions pending in CAT Ernakulam Bench/Kerala High Court/Supreme Court of India or any other Jurisdictional Court of India and/or directions received from DoP&T and/or CBDT.


