No.35034/3/2008-Estt.(D) dated 19.05.2009 [Item no.4 of Annexure-I] prior to sanctioning the same.
- 5. If the officer opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 08.12.2017.
- 6. On promotion to the grade of AO Gr.II, Smt. Subhalekshmi Ammai R is posted as AO Gr.II, O/o. Pr.CIT, Thiruvananthapuram. This posting will be reviewed in AGT-2018.
- 7. Concerned Heads of Offices shall inform the date of joining/relieving of the above officer in their office by 08.12.2017.
