Sub.: Estt. Group 'B' Gazetted – Administrative Officer Grade-II – Promotion – reg.

Shri. S. Raveendranath, Administrative Officer Grade-III, O/o. Pr. Commissioner of Income Tax, Kottayam is hereby promoted to officiate as Administrative Officer Grade-II in the pay band + grade pay of Rs.9300-34800/- + Rs.4800/- with immediate effect.

2. The above promotion is purely on provisional basis and is liable to termination for any administrative or other reason at any time without notice. The above promotion will not confer on the promoted official any right either to retention or to seniority in the promoted cadre.
3. The promoted official is informed that his seniority is liable to be changed due to judicial/administrative or due to any other reason.
4. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2008. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of official for the increase in total pay by 3% at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.
5. If the official opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 04.12.2015.
6. On promotion to the grade of AO Gr.II, Shri. S. Raveendranath is posted as AO Gr.II, O/o. Pr.CIT, Kottayam. This posting is liable to be reviewed during AGT 2016.
