As decided in the Secretariat Meeting of ITEF (CHQ.) held on 1<sup>st</sup> March, 2016 at Rajouri Garden, New Delhi, the demand of higher pay for the grades of ITOs, ITIs and TAs (at par with the officials of IB / CBI and various other Departments) than what was recommended by the 7<sup>th</sup> CPC has been raised before the Hon'ble Minister of State (Revenue), Revenue Secretary, the Chairman, CBDT and the Chairman, Implementation Cell, Govt. of India while meeting them separately and the memorandum prepared in this regard was submitted to them for their immediate intervention. It was further decided in the above said secretariat meeting to chalk out campaign program for the month of April-May 2016 before finalization of agitation program.

It was also decided to explore the possibility of reviving the Co-ordinating Committee of Revenue Department (CoC) so that the Department specific issues pertaining to 7<sup>th</sup> CPC could be pursued jointly. As per the decision taken, the apex level leadership of ITEF, ITGOA and various service organizations of CBEC met on 28<sup>th</sup> March, 2016 at C R Building New Delhi. It was decided to revive state Revenue C-o-Cs. It was also decided that the campaign program would be organized, wherever possible, in the banner of Revenue CoC. Minutes of the meeting of CoC is also attached with this Circular. The Chart containing campaign program of ITEF has been finalized and placed in the website. All the Circle Secretaries are requested to contact the concerned CHQ leaders immediately and finalize the date and venue of the said program and make it a grand success.

The Central JCA brought the issue of large number of pending applications for compassionate appointment of the dependents of the employees of I.T. Department, who died in harness, to the kind notice of the Hon'ble Minister of State (Revenue) in the meeting dated 31-03-2016. It was mentioned before the Hon'ble Minister that the pendency was created due to the ceiling of 5% of Direct Recruitments, imposed on all compassionate appointments by the Department of Personnel and Training. The Central JCA pleaded that a onetime relaxation of the ceiling of 5% was needed in order to consider the cases which would be fit for compassionate appointments. The Hon'ble MoS (Revenue) directed the Department to collect the facts & figures in relation to the actual requirement regarding that issue. The Central JCA has submitted a letter to the Hon'ble MoS (Revenue) on 12-04-2016 requesting him to kindly issue necessary instruction to expedite the matter.

The circular dated 4<sup>th</sup> April 2006 of the Confederation of CG Employees regarding All India Trade Union Education Camp to be held at Dehradun on 24<sup>th</sup> & 25<sup>th</sup> May 2016 is enclosed and all Circle Secretaries are requested to nominate one Comrade each for the Education Camp and

intimate the CHQ. Accordingly, latest by 30<sup>th</sup> April 2016.

Regarding finalization of Recruitment Rules of Inspector and Executive Assistant, we have circulated the objections raised by the DoPT to all Circle Secretaries. The ITEF CHQ has already submitted a Note in this regard to the ADG-II, HRD, CBDT.

The proposal for withdrawal of the ban on inter charge transfer (ICT) is pending with the CBDT. The order will likely be issued after necessary approval of the Member (P) and the Chairman, CBDT only for those members who have completed three years in their respective charges. The CBDT already constituted a committee to look into the existing policy and to frame a new policy regarding inter charge transfer on compassionate grounds. We have submitted our views before the committee but the minutes of the meeting is yet to be received.

The Board has issued the instruction along with the DoPT OM dated 2<sup>nd</sup> March 2016 regarding recovery of wrongful / excess payments made to Government servants after granting MACP benefit. The CBDT is going to issue clarifications regarding treatment of promotion in same grade pay for the purpose of determining eligibility for financial upgradation under MACP.

It was decided in the meeting with ADG,Admn.(Exam),CBDT that the departmental examinations for 2016 would be held from 18<sup>th</sup> July, 2016. Necessary order has not yet issued by the concerned authority. The eligibility norms for appearing Ministerial Exam has already been issued and the staff members in MTS grade are now eligible to appear in the Ministerial Exam. We have already submitted a letter requesting for inclusion of staff members in the grade of NS in the said examination.
