## ORDER NO.49/2015-16

Sub.: Estt. -Non-Gazetted – Inspector of Income Tax – Promotion and Posting – reg. Order No.41 &43/2015-16 dated 16th July 2015. Ref.:

It is hereby ordered that the deemed date of promotion to the grade of Inspector of Income Tax in the case of officials promoted vide this Office Order No.41/2015-16 referred to above will be 19.12.2014.

Accordingly, the pay of the officials are to be notionally fixed in the grade of ITI w.e.f. 2. 19.12.2014.

On account of promotion to the grade of ITI notionally w.e.f. 19.12.2014, the pay of the 3. following officials are to be fixed as if they are promoted from the grade of Senior Tax Assistant to the grade of Inspector of Income Tax w.e.f. 19.12.2014, as their date of Order of promotion to the grade of Office Superintendent [i.e. 30.12.2014] succeeded their deemed date of promotion as ITI.
