The under mentioned officials are hereby promoted to officiate in the grade of Inspector of Income Tax in the pay band + grade pay of Rs.9300-34800/- + Rs.4600/- with immediate effect.

3. The promotion of Shri K. Mohan has been ordered against PHC quota from the extended zone of consideration, treating the classification of the post as Group 'C'. However, the Hon'ble Central Administrative Tribunal, Ernakulam Bench, Ernakulam in its judgment in O.A. No.1103/2010 has set aside the direction of CBDT to the effect that ITI is a Group 'C' post and upheld the classification of posts ordered by the DOP&T vide their Order S.O.946(E) in F.No.11012/7/2008-Estt.(A) dated 09.04.2009 and as per the said Order, the post of ITI has been classified as Group 'B'. If the Board decides to accept the judgment of Hon'ble CAT in O.A. No.1103/2010, Shri K. Mohan will lose his position in this Order as there is no reservation prescribed for PHC against Group 'B' vacancies.

4. The above promotions are purely on provisional basis and are liable to termination for any administrative or other reason at any time without notice. The above promotions will not confer on the promoted officials any right either to retention or to seniority in the promoted cadre.

5. The promoted officials are informed that their seniority is liable to be changed due to judicial/administrative or due to any other reason.

6. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2008. If any of the officials has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay by 3% at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.

7. On promotion to the grade of Inspector of Income Tax, the above officials are posted to the same office in which they are presently working.


8. The posting of the above officials will be reviewed during AGT-2013.
