Sub.: Estt. Group 'B' Gazetted - Income Tax Officer - Promotion & Posting - reg. -

Smt. P.B. Jayadevi, Inspector of Income Tax, O/o. Commissioner of Income Tax, Kottayam is hereby promoted to officiate in the grade of Income Tax Officer in the pay band + grade pay of Rs.9300-34800/- + Rs.4800/- with immediate effect.

2. The above promotion is purely on provisional basis and is liable to termination for any administrative or other reason at any time without notice. The above promotion will not confer on the promoted official any right either to retention or to seniority in the promoted cadre.
3. The promotion of the official mentioned above will be subject to review while implementing the Hon'ble Supreme Court judgment dated 27.11.2012 in the case of UOI & Others Vs. N.R. Parmar & Others in Civil Appeal No.7514-7515 of 2005.
4. The promoted official is informed that her seniority is liable to be changed due to judicial/administrative or due to any other reason.
5. Fixation of pay of the above official in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2008. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of official for the increase in total pay by 3% at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.
5. On promotion to the grade of Income Tax Officer, Smt. P.B. Jayadevi is posted as Tax Recovery Officer, Kottayam. The posting of the official will be reviewed during AGT-2014.
6. The promoted officials shall be relieved on or before 30.01.2014 [AN] by the concerned Head of Office, unless he/she declines promotion. If the official opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 28.01.2014.
