Sub.: Review of promotions to the grade of ITO effected during the vacancy years 2011-12 and 2012-2013 consequent upon the issue of revised mark list in the case of Shri A.J. Prijilal [Roll No.7488] for the ITO Betterment (Old Pattern) 2010 Examination by the O/o. CIT-I, Kochi vide Corrigendum No.CIT-I/ CHN/ DE/2012-13 dated 11.02.2013, thereby withdrawing the results published vide letter in C.No.67/CIT/CHN/ DE/Results/ITOs/2011-12 dated 25.05.2011 - Regarding.

Shri A.J. Prijilal, official belonging to SC category, was declared to have qualified the Departmental Examination for ITO, 2010 in 'General Merit' by the O/o. CIT, Kochi vide letter referred to at SI.No.(i) above and he was accordingly promoted against General category vacancy by the Cadre Controlling Authority in the vacancy year 2011-12. However, the Departmental Examination result was subsequently modified by the O/o. CIT-I, Kochi vide Corrigendum referred to at SI.No.(iii) above on the basis of DIT[IT], New Delhi's letter/clarification referred to at SI.No.(iii) above and a revised mark list was also published in respect of Shri A.J. Prijilal.

- 2. On the basis of the above, Shri A.J. Prijilal was not to be considered against General category vacancy and he was to be accommodated only against SC category vacancy in accordance with his seniority in that category. However, he is occupying General category slot in the Post Based Roster as he was promoted against General category vacancy of 2011-12 on the basis of Departmental Examination results published by the O/o. CIT, Kochi vide SI.No.(i) referred to above. A Review DPC was convened on 06.05.2013 in order to rectify this position and on the basis of the Review DPC recommendations the following are hereby ordered with immediate effect.
 - Consequent upon losing the seniority position assigned against General category vacancy in the Select List for the vacancy year 2011-12, Shri A.J. Prijilal finds his position in the Select List for promotion to the grade of ITO in the vacancy year 2012-13 on the basis of his seniority position in the Consideration List for SC category and he will replace Shri C.S. Venu [SC] in the Post Based Roster slot belonging to SC category. As a consequence, Shri C.S. Venu [SC], who has qualified the Departmental Examination for ITOs under relaxed standards prescribed for that category, cannot find a place in the Select List for the vacancy year 2012-13 due to non-availability of another SC vacancy during the vacancy year 2012-13 after accommodating Shri A.J. Prijilal. In view of the above, the promotion to the grade of ITO ordered vide this office order of even number dated 12.04.2012 in the case of Shri C.S. Venu against the SC category vacancy of 2012-13 stands cancelled. Accordingly, Shri C.S. Venu stands reverted to the grade of Inspector of Income Tax with immediate effect.
 - ii) Smt. Jancy Thomas, Inspector of Income Tax, O/o. Jt.CIT, Central Range, Kochi stands promoted to the grade of Income Tax Officer with effect from 07.02.2013 and the terms and condition of her promotion will be the same as that prescribed in this office promotion order to ITO grade, of even number dated 07.02.2013.
 - Consequent upon the above the seniority position and date of promotion of the officials who were promoted to the grade of ITO from the vacancy year 2011-12 to till date stands re-assigned as shown below.

- 8. On reversion to the grade of Inspector of Income Tax, Shri C.S. Venu is posted to the office of the Jt. Commissioner of Income Tax, Central Range, Kochi with immediate effect.
