Sub : Implementation of judgment of the Hon'ble CAT, Ernakulam Bench, Ernakulam dated 10/12/2012 in O.A. No.225/2011 - Promotion to the grade of ITO in respect of Shri C.J. Babu and consequential re-assigning of seniority position of officials in the grade of ITO - Regarding.

Ref : Judgment of the Hon'ble Central Administrative Tribunal, Ernakulam Bench, Ernakulam in O.A. No.225/2011 dated 10/12/2012 - C.J. Babu, ITI Vs. UOI & Others.

In pursuance to the directions contained in the reference shown above, Shri C.J. Babu, Inspector of Income Tax, Office of the Commissioner of Income Tax [Audit], Kochi stands promoted to the grade of Income Tax Officer with effect from 10.03.2011 and the seniority position in the grade of ITO will be below Shri C. Asok Kumar and above Smt. S. Retnavally.

2. The promotion of Shri C.J. Babu to the grade of ITO is ordered subject to the outcome of any appeal that may be filed against the judgment of Hon'ble CAT under reference and without prejudice to any stand being taken by the Govt. of India before the High Court / Supreme Court of India.
