(3) Any changes in the above postings including additional charges within the station and within the jurisdiction of the respective Commissioners/Directors shall be effected only with the prior approval of the Principal Chief Commissioner of Income Tax, Kerala.

(4) The officers under orders of transfer shall relinquish existing charge latest by 26.06.2015. The handing over note prepared shall be given to the successor incorporating all pending actions requiring immediate attention, with a copy to their superior officers.

(5) Concerned Heads of Offices shall inform the date of relieving/joining of the above officers in their

office by 03.07.2015.
