4. The promoted officials are informed that their seniority is liable to be changed due to judicial/administrative or due to any other reason.
5. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2008. If any of the officials has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay by 3% at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.
5. If the official opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 06.05.2016. The date of joining of the promoted officials is to be intimated by the corresponding Head of Office by 09.05.2016.
