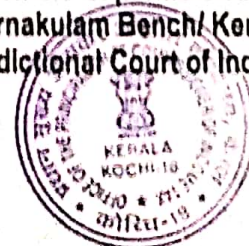
2. On promotion to the cadre of Office Superintendent, the officials are posted in the same office where they are presently working and they will continue to do the duties presently assigned to them until further orders. The postings will be reviewed during next AGT or on the basis of administrative requirement, whichever is earlier.

3. The promoted officials will be on probation for a period of 2 years from the date of joining on promotion. The promoted officials are informed that his/her promotion/seniority is liable to be changed due to any judicial/administrative orders/decisions or due to any other reason. The above promotions will not confer on the promoted officials any right either to retention or to seniority in the promoted cadre.

4. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanctioning the same.

5. The above promotion is subject to the outcome of the following cases.

- Special Leave Petition to Appeal No.30621 &Ors. Vs. LachmiNarain Gupta &Ors. and all other related cases pending before the Hon'ble Supreme Court.
- Outcome of various decisions pending in CAT Ernakulam Bench/ Kerala High Court/Supreme Court of India or any other Jurisdictional Court of India and/or directions received from DoPT and/or CBDT.



6. If the official opts to decline promotion, he/she is directed to inform the same to this office through Head of office on or before 08.01.2021

7. The Heads of Office concerned shall inform the date of joining of the above official in their office by 11.01.2021.
