The Permanent Grievance Redressal Committee met in the chamber of CCIT (CCA), Kochi at 3:30 P M on October 01, 2013, The meeting was attended by

The meeting commenced with the CCIT (CCA)'s opening remarks welcoming the members.

2. The representatives of the ITEF raised the issue of appointments under Sports quota. It was stated that 5 % of the Direct Recruit vacancies which can be earmarked for sports quota needs to be filled. It was pointed by the CCIT (CCA) that due to the present austerity measures put in place, this cannot be considered at present.

3. The issue of compassionate appointments was also raised by the ITEF. It was clarified from the official side that pending compassionate appointments till 30.06.2013 has been disposed of. Other applications received later have been forwarded to the committee of Commissioners for recommendations to be given at the earliest.

4.It was also raised that the lift in Kozhikode office is in a bad shape and there can be dangers to people who board it. It was stated that CPWD had not taken speedy action. The correspondence with DIT (Infra) and CIT, Kozhikode entered into by this office was stated in the meeting. It was suggested that CIT, Kozhikode, being a separate budgetary authority can request for funds from DIT (Expenditure Budget) and proceed with the work , which is less than ₹ 30 lakh in accordance with the provisions of the GFR, 2010. The CCIT (CCA) also stated that CIT, Kozhikode can bring the attention of CPWD to the perceived danger in boarding the present lift.

5. Transfer of Krishnan Kutty: MTS Shri Krishnan Kutty was recruited as Washboy in Thrissur. He has been given training in MSTU for redesignating him as MTS. Transfer will be considered on merits.

6. As regards, conducting skill test for MTS for being eligible for promotion as TAs, it was decided that the practice followed in other charges can be followed in Kochi charge also.

7. Pay anomaly and denial of promotion issue raised will be considered and disposed of by the CCIT (CCA)'s office in a time bound manner and disposed of within two months,

8. The ITEF and ITGOA representatives raised the issue of pending reimbursement of pending mobile bills prior to introduction of Tarang scheme. The CCIT (CCA) immediately spoke to the concerned Commissioners and directed them to settle the issue as per existing rule.

9. The ITGOA representatives raised the issue of sharing ITR/CTR online through wi-fi facilities within the Tarang scheme, by sharing passwords. It was decided to discuss the issue with BSNL officials.

10. The ITGOA representatives raised the issue of completion of APARs in a time bound manner. It was informed that this was not a grievance matter and the administration is taking steps to ensure this.

11. It was also stated by the administration side that laptops are being repaired and distributed to newly promoted ITOs on first come first basis.

The meeting concluded with the CCIT (CCA) thanking the members for a useful discussion.
