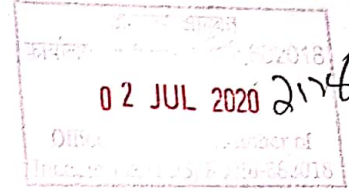

- On promotion to the cadre of Administrative Officer Gr.III, the officials are posted in the same office where they are presently working and they will continue to do the duties presently assigned to them until further orders. The postings will be mandatorily reviewed in AGT 2020.
- The promoted officials will be on probation for a period of 2 years. During this period, the above promotion will not confer on the promoted official any right either to retention or to seniority in the promoted cadre.
- Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of official for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned Head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanction the same.
- The promoted officials are informed that his/her promotion/seniority is liable to be changed due to any judicial/administrative orders/decisions or due to any other reason. The above promotions will not confer on the promoted official any right either to retention or to seniority in the promoted cadre.
- The above promotion is subject to the outcome of the following cases.
 - Writ Petition No.308/2017 pending before the Hon'ble High Court of Kerala in the case of Smt. Ajitha K & Another and all other related matters.
 - Special Leave Petition to Appeal No.30621 &Ors. Vs. Lachmi Narain Gupta &Ors. and all other related cases pending before the Hon'ble Supreme Court.

8. The Heads of Office concerned shall inform the date of joining of the above officials in their office by 07.07.2020.


