- 2. On promotion to the cadre of Administrative Officer Gr.III, the official is posted in the same office where he/she is presently working and will continue to do the duties presently assigned to him/her until further orders. The postings will be mandatorily reviewed in AGT 2021.

No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanction the same.
- 5. The promoted official is informed that his/her promotion/seniority is liable to be changed due to any judicial/administrative orders/decisions or due to any other reason. The above promotions will not confer on the promoted official any right either to retention or to seniority in the promoted cadre.
- 6. The above promotion is subject to the outcome of the following cases.
 - i) Special Leave Petition to Appeal No.30621 &Ors. Vs. Lachmi Narain Gupta &Ors. and all other related cases pending before the Hon'ble Supreme Court.
 - Outcome of various decisions pending in CAT Ernakulam Bench/ Kerala High Court/Supreme Court of India or any other Jurisdictional Court of India and/or directions received from DoPT and/or CBDT.

- 7. If the official opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 08.01.2021
- 8. The Heads of Office concerned shall inform the date of joining of the above officials in their office by 11.01.2021.
