 - i) Special Leave Petition to Appeal No.30621/2011 Jarnail Singh &Ors. Vs. Lachmi Narain Gupta & Ors and all other related cases pending before the Hon'ble Supreme Court.
 - ii) Outcome of various decisions pending in CAT Ernakulam Bench/Kerala High Court/Supreme Court of India or any other Jurisdictional Court of India and/or directions received from DoP&T and/or CBDT in N.R Parmar case vide letter dated 27.05.2019 & directions issued by CBDT in K.Meghachandra Singh case vide letter dated 26.10.2021 read with DoP&T OM dated 13.08.2021 and other similar cases on matter pending, if, any in various courts (Supreme Court/High Court/CAT etc.)
4. Fixation of pay of the above official in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement officials for

the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned Head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanctioning the same.
