The above promotion[s] is/are likely to be reviewed on a later date upon implementation of decision of the Hon'ble CAT, Ernakulam Bench in OA No.143/2019 and also on the basis of giving effect to the Hon'ble Supreme Court's judgment dated 27.11.2012 in the N R Parmar case prospectively with reference to CBDT's instructions in F.No.A-35015/26/2018-Ad.VI dated 27.05.2019.

5. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement officials for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned Head of office with reference to Department of Personnel & Training's O.M.

No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanctioning the same.


