- 2. On promotion to the cadre of Office Superintendent, the official is posted in the same office where he/she is presently working and he/she will continue to do the duties presently assigned to him/her until further orders. The postings will be reviewed during next AGT or on the basis of administrative requirement, whichever is earlier.
- 3. The promoted official will be on probation for a period of 2 years from the date of joining on promotion. The promoted official informed that his/her promotion/seniority is liable to be changed due to any judicial/administrative orders/decisions or due to any other reason. The above promotions will not confer on the promoted officials any right either to retention or to seniority in the promoted cadre.
- 4. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanctioning the same.

i) Special Leave Petition to Appeal No.30621 &Ors. Vs. LachmiNarain Gupta &Ors. and all other related cases pending before the Hon'ble Supreme Court.

ii) Outcome of various decisions pending in CAT Emakulan Bench/ Kerala High Court/Supreme Court of India or any other Junisdictional Court of India and/or directions received from DoPT and/or CBDI
