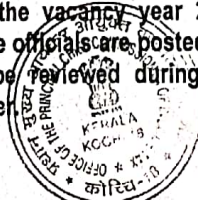

The above promotions are liable to be reviewed/withdrawn subject to the final outcome of the OAs No.297/2016, 770/2016, 83/2017 and 326/2017 filed before the Hon'ble Central Administrative Tribunal, Ernakulam Bench, Ernakulam or any other administrative/executive direction or judicial orders in this regard and in accordance with the existing Recruitment Rule of Tax Assistant.
4. The promoted officials are informed that his/her promotion/seniority is liable to be changed due to any judicial/administrative orders/decisions or due to any other reason. The above promotions will not confer on the promoted officials any right either to retention or to seniority in the promoted cadre.
5. The above promotions are also subject to the outcome of the following cases.
 - i) Special Leave Petition to Appeal No.30621 & Ors. Vs. Lachmi Narain Gupta & Ors. and all other related cases pending before the Hon'ble Supreme Court.
 - ii) Outcome of various decisions pending in CAT Ernakulam Bench/ Kerala High Court/Supreme Court of India or any other Jurisdictional Court of India and/or directions received from DoPT and/or CBDT.
6. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules 2016. If any of the officials has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the Head of Office concerned with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanctioning the same.
7. The Heads of Office concerned shall send the compliance report by 08.01.2020.
