- 4. The promoted officials are informed that his/her promotion/seniority is liable to be changed due to any judicial/administrative orders/decisions or due to any other reason. The above promotions will not confer on the promoted officials any right either to retention or to seniority in the promoted cadre.
- The above promotions are also subject to the outcome of the following cases.
