4. The promoted officials are informed that his/her promotion/seniority is liable to be changed due to any judicial/administrative orders/decisions or due to any other reason. The above promotions will not confer on the promoted officials any right either to retention or to seniority in the promoted cadre.

6. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules 2016. If the official has been granted financial upgradation



under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such official for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the Head of Office concerned with reference to Department of Personnel & Training's O.M. 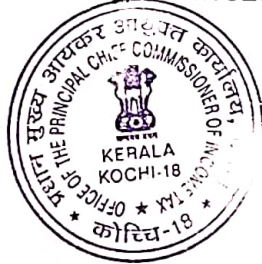
7. If the official opts to decline promotion, he/she is directed to inform the same to this office through Head of office on or before 08.01.2021.
