- On reversion to the cadre of MTS, the above officials are posted to the same office in which they are presently working.
- The pay of the above officials is to be re-fixed at a stage they would have normally drawn but for their promotion [under reference that was carried out earlier] as Tax Assistant. However, no recovery of pay should be made on account of revised fixation of pay of the above officials during the period they functioned as Tax Assistant. However, the services rendered in the post of Tax Assistant in respect of these officials will not be counted for the purpose of increments or for any other purpose in that grade/post to which they would not normally be entitled but for the promotion under reference that was carried out earlier. The seniority of the above officials will be restored back to the seniority which existed in their feeder cadre from which they were promoted.
- The Heads of Office concerned are directed to re-fix the pay of the officials accordingly with necessary entry in the Service Book.
