Note-1

30 candidates had been nominated by SSC w.r.t. this office's requisition dated 04.11.1996. Out of these, 26 have reported. On the basis of requisition date they are to be assigned seniority of the year 1996-97 in the 'Revised seniority position on implementation of the judgement in N.R. Parmar case'. However, on the basis of availability of vacancies (12), the first 12 candidates were assigned seniority position of 1996-97 and thereafter the officials have been accommodated against the DR vacancy slots arose thereafter. Since all the DR officials had been assigned seniority position above 'S. Lalithambika' in the 'Existing seniority List,' all the remaining DR officials have been placed enbloc above 'S. Lalithambika' in the 'Revised seniority position' presuming that DR vacancies were available there at that point of time.

Note-2

The claim of DR officials for refixing their seniority of the year 1993 on the basis of their year of exam cannot be entertained as there were no DR vacancies available in 1993 till the promotion of 'Mohan Paul'. The 22 DR vacancies available till July, 1993 were diverted to Promotion Quota and the vacancies were filled up by promotion on the basis of the instructions contained in CBDT's F.No.A-12018/19/93-Ad.VII dated 29.10.1993.

Note-3

Jacob George' had been appointed against 'Sports Quota' and his seniority position was not to be disturbed. This fact was omitted at the time of circulation of the revised draft seniority position. The omission stands rectified here.
