The promoted officials are informed that their ad hoc promotions are liable to be reviewed/withdrawn subject to the final outcome of the Original Application No.959/2015 filed before the Hon'ble Central Administrative Tribunal, Ernakulam Bench, Ernakulam or any other judicial orders or administrative/executive directions in this regard and in accordance with the existing Recruitment Rule of Inspector of Income Tax.

The promoted officials are also informed their ad hoc promotions shall not confer any right to the promoted officials for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoPT as contained in OM No.28036/8/87 –Estt.[D] dated 30.03.1988 and instructions issued by DoPT/CBDT from time to time. The ad hoc promotions are liable to be terminated at any point of time without giving any reason therefore.
5. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement officials for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.


6. If any of the officials opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 20.02.2017
