3. The Committee will discuss the issues with all stake-holders including representatives of recognized Associations of Staff and Officers. Shri R. Mohan, Addl.CIT[HQ][Admn./Vig.] and Shri Pradumna Kumar Singh, DCIT[HQ][Admn.], O/o. Pr.CCIT, Kerala shall associate with the Committee from O/o. Pr.CCIT, Kerala as non-Member Secretaries.
4. The Committee shall furnish its report to the Principal CCIT, Kerala by 29th July, 2014 positively.
