- 2. Representations were received from few inter charge transferee officials requesting for placing them immediately after the officials who have cleared the departmental examination for ITI till their joining in this charge. Subsequently Shri Veenadharan K.V & Ors has preferred OA No.959/2015 before the Hon'ble CAT, Ernakulam Bench. They have placed reliance on a letter issued by the CBDT dated 25th Jaunary 2003. Since the reliance has been placed on the said circular after a gap of more than 13 years and it is not clear whether any letter/order has been issued withdrawing the same, clarification has been sought for from the CBDT and the matter is still pending. It is further stated that the Hon'ble CAT has not stayed the existing practice being followed by this Charge as regards assigning of seniority of inter-charge transferees.
- 3. Since the matter is sub-judice and satisfaction on continued prevalence of the said circular is to be drawn, it has decided that the present policy may be continued le without considering the representations relying on letter dated 25.01.2003 subject to the final outcome of the case pending before Hon'ble CAT and obtaining necessary clarification from CBDT as regards the validity of the circular. It is also noted that the petitioners in OA No.959/2015 has not relied on the circular directly or indirectly before the Hon'ble CAT.
- 3. The promotion of all the officials in the list approved by DPC and competent authorities are liable to be reviewed/withdrawn subject to the final outcome of the Original Application No.959/2015 filed before the Hon'ble Central Administrative Tribunal, Ernakulam Bench, Ernakulam or any other administrative/executive directions in this regard and in accordance with the existing Recruitment Rule of Inspector of Income Tax.
- The officials are promoted against the vacancies of the year 2016-17 and seniority of the officials will be intimated separately.

- 5. The above promotions are purely on provisional basis and are liable to termination for any administrative or other reason at any time without notice. The above promotions will not confer on the promoted officials any right either to retention or to seniority in the promoted cadre.
- 6. The promoted officials are informed that their seniority is liable to be changed on basis of judicial/administrative orders/instructions or due to any other reason.
- 7. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2008. If any of the officials has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay by 3% at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.
- 8. If the official opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 03.06.2016
- 9. On promotion to the grade of ITI, the officials are posted in the same office on insitu basis. Posting Orders will be issued along with AGT 2016.
