If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of official for the increase in total pay by 3% at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.

- 6. If the official opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 19.04.2016.
- 7. The posting order in respect of the promoted officers/officials will be issued separately.
