- (3) The officers under orders of transfer shall relinquish existing charge latest by 29.04.2016. The handing over note prepared shall be given to the successor incorporating all pending actions requiring immediate attention, with a copy to their superior officers.
- (4) Concerned Heads of Offices shall inform the date of relieving/joining of the above officers in their office by 04.05.2016.
- (5) Smt. Lalibai Rajasekharan shall not be entitled for TA/DA/JT etc.
- (6) If any of the above Officers are entrusted with duties relating to election to Legislative Assembly of Kerala, he/she will be relieved only after completion of entire election process or 20<sup>th</sup> May 2016 whichever is later.
