3. The promoted official is informed that his seniority is liable to be changed due to judicial/administrative or due to any other reason.
4. Fixation of pay of the above official in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2008. If the official has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay by 3% at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 [item no.4 of Annexure-I] prior to sanctioning the same.
5. On promotion to the grade of Office Superintendent, Shri C.F. Tony is posted to the same office in which he is presently working. The posting will be reviewed during AGT-2013.
