2. On promotion to the cadre of Inspector of Income Tax on ad-hoc basis, the officials are posted in the same office where they are presently working and they will continue to do the duties presently assigned to them until further orders.

3. The promoted officials are informed that their *ad hoc* promotions shall not confer any right to the promoted officials for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoPT as contained in OM No.28036/8/87 -Estt.[D] dated 30.03.1988 and instructions issued by DoPT/CBDT from time to time. The *ad hoc* promotions are liable to be terminated at any point of time without giving any reason therefore. The officials are also further informed that they are liable to be reverted to feeder grade[s], if after review of the vacancy position if any, in future or for any other administrative or judicial reason, it is considered necessary to do so.

4. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If any of the officials has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanctioning the same.



5. The above promotions are subject to the outcome of the following cases.
- Special Leave Petition to Appeal No.30621 &Ors. Vs. LachmiNarain Gupta &Ors. and all other related cases pending before the Hon'ble Supreme Court.
  - Outcome of various decisions pending in CAT Ernakulam Bench/ Kerala High Court/Supreme Court of India or any other Jurisdictional Court of India and/or directions received from DoPT and/or CBDT.
6. If any of the officials opts to decline promotion, he/she is directed to inform the same to this office through head of office on or before 07.05.2021.
7. The Heads of Office concerned shall inform the date of joining of the above officials in their office by 10.05.2021.
