The promoted officials are informed their *ad hoc* promotions shall not confer any right to the promoted officials for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoPT as contained in OM No.28036/8/87 -Estt.[D] dated 30.03.1988 and instructions issued by DoPT/CBDT from time to time. The *ad hoc* promotions are liable to be terminated at any point of time without giving any reason therefore. The officials are also further informed that they are liable to be reverted to the post of STA, if after review of the vacancy position if any, in future or for any other administrative or judicial reason, it is considered necessary to do so.

4. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2016. If any of the officials has been granted financial upgradation under the Modified Assured Career Progression Scheme [MACPS], the entitlement of such officials for the increase in total pay at the time of fixation of pay on promotion is required to be verified by the concerned head of office with reference to Department of Personnel & Training's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and O.M.No.35034/3/2015-Estt[D] dated 22.10.2019 prior to sanctioning the same.
