- 3. The *inter* se seniority of the promoted officials will be fixed according to rules and orders in the matter and will be issued separately.
- 4. The promoted official is informed that her seniority is liable to be changed due to judicial/administrative or due to any other reason.
- 5. Fixation of pay of the above officials in the promoted cadre shall be made with reference to the CCS (Revised Pay) Rules, 2008.
- 6. On promotion, Smt. Sini M. Vasu is posted to the O/o. Commissioner of Income Tax, Kozhikode.
