The Hon'ble Central Administrative Tribunal, Ernakulam Bench vide interim direction dated 04.03.2016 [in OA No. 549/2015] had directed this office to promote the applicants therein provisionally subject to the final outcome of the said OA. 
On reversion to the post of Tax Assistants, the above officials are posted to the same office in which they are presently working.
